# Proposition No. 1

Shall the bond resolution adopted by the Board of Education of the City School District of the City of Oswego (the "District") on January 4, 2018, which (1) authorizes the reconstruction, improvement, rehabilitation, repair, furnishing and equipping of Oswego High School, Oswego Middle School, Fitzhugh Park Elementary School, Kingsford Park Elementary School, Riley Elementary School, Leighton Elementary School and Minetto Elementary School, including site work and the acquisition of original furnishings, equipment, machinery and apparatus required for the purposes for which such buildings are to be used, at a maximum estimated cost of \$60,180,000; (2) authorizes the issuance of up to \$56,180,000 serial bonds of the District and the expenditure of up to \$4,000,000 from the District's Capital Reserve Fund to finance the cost of such capital projects; (3) provides for the levy of taxes on the taxable real property within the District to be collected in annual installments to pay debt service on obligations issued to finance such

capital projects; and (4) pledges the District's faith and credit for payment of bond anticipation notes and such bonds, be approved?
