BOND RESOLUTION DATED OCTOBER 16, 2018

A RESOLUTION AUTHORIZING THE RENOVATION AND IMPROVEMENT OF CERTAIN SCHOOL DISTRICT BUILDINGS AND FACILITIES BY THE CITY SCHOOL DISTRICT OF THE CITY OF OSWEGO, OSWEGO COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$63,100,000 AND AUTHORIZING THE ISSUANCE OF \$57,200,000 SERIAL BONDS TO PAY THE COSTS THEREOF.

WHEREAS, the Board of Education of the City School District of the City of Oswego, Oswego County, New York (the "School District") has determined it is the best interests of the School District to undertake the reconstruction, improvement, rehabilitation, repair, furnishing and equipping of Oswego High School, Oswego Middle School, Fitzhugh Park Elementary School, Kingsford Park Elementary School, Riley Elementary School, Leighton Elementary School and Minetto Elementary School, including site work and the acquisition of original furnishings, equipment, machinery and apparatus required for the purposes for which such buildings are to be used; and

WHEREAS, the requirements of the New York State Environmental Quality Review Act applicable to the capital projects described above have been met; and

WHEREAS, it is now desired to provide for the financing of such capital projects.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the City School District of the City of Oswego, New York, as follows:

<u>Section 1</u>. The School District is hereby authorized to undertake the reconstruction, improvement, rehabilitation, repair, furnishing and equipping of Oswego High School, Oswego Middle School, Fitzhugh Park Elementary School, Kingsford Park Elementary School, Riley Elementary School, Leighton Elementary School and Minetto Elementary School, including site work and the acquisition of original furnishings, equipment, machinery and apparatus required for the purposes for which such buildings are to be used, at a total estimated maximum cost not to exceed \$63,100,000.

Section 2. The plan for financing of such maximum estimated cost shall consist of the following:

- a. the issuance of up to \$57,200,000 serial bonds (the "Bonds") of the School District, which are hereby authorized pursuant to the provisions of the Local Finance Law; and
- b. the appropriation and expenditure of up to \$5,900,000 from the School District's Capital Reserve Fund, which are hereby authorized.

<u>Section 3</u>. The Board of Education hereby determines that the obligations authorized by this resolution may be issued in excess of the constitutional debt limitation of the School District.

<u>Section 4</u>. It is hereby determined that the period of probable usefulness of the aforesaid objects or purposes is thirty (30) years pursuant to subdivision 97 of paragraph a of Section 11.00 of the Local Finance Law.

<u>Section 5</u>. Subject to the provisions of this resolution and of the Local Finance Law, and pursuant to the provisions of Sections 21.00, 30.00, 50.00 and 56.00 to 63.00, inclusive, of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the Bonds herein authorized, including renewals of such notes, and the power to prescribe the terms, form and contents of the Bonds, and any bond anticipation notes, and the power to sell and deliver the bonds and any bond anticipation notes issued in anticipation of the Bonds (including sale by electronic bidding), and the power to issue Bonds providing for substantially level or declining annual debt service, is hereby delegated to the President of the Board of Education, the chief fiscal officer of the School District.

<u>Section 6</u>. The temporary use of available funds of the School District, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this resolution.

<u>Section 7</u>. The reasonably expected source of funds to be used to initially pay for the expenditures authorized by Section 1 of this resolution shall be from the School District's General Fund. It is intended that the School District shall then reimburse expenditures from the General Fund with the proceeds of the Bonds and bond anticipation notes authorized by this resolution and that the interest payable on the Bonds and any bond anticipation notes issued in anticipation of the Bonds shall be excludable from gross income for federal income tax purposes. This resolution is intended to constitute the declaration of the School District's "official intent" within the meaning of Treasury Regulation Section 1.150-2 to reimburse the expenditures authorized by this resolution with the proceeds of the Bonds and bond anticipation notes authorized on a long-term basis, or otherwise set aside with respect to the permanent funding of the objects or purposes described herein.

<u>Section 8</u>. The faith and credit of the School District are hereby irrevocably pledged to the punctual payment of the principal of and interest on the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, and provision shall be made annually in the budget of the School District by appropriation for (a) the amortization and redemption of the Bonds and bond anticipation notes to mature in such year, and (b) the payment of interest to be due and payable in such year.

<u>Section 9</u>. The Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law. The Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall be general obligations of the School District, payable as to both principal and interest by a general tax upon all the taxable real property within the School District, without legal or constitutional limit as to rate or amount, such tax to be collected in annual installments in the years and amounts as the Board of Education shall determine in accordance with Section 416 of the Education Law.

<u>Section 10</u>. The validity of the Bonds or any bond anticipation notes issued in anticipation of the sale of the Bonds may be contested only if:

- a. such obligations are authorized for an object or purpose for which the School District is not authorized to expend money; or
- b. the provisions of law which should be complied with at the date of the publication of this resolution or a summary hereof are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days (20) days after such publication; or
- c. such obligations are authorized in violation of the provisions of the Constitution.

<u>Section 11</u>. The President of the Board of Education, as chief fiscal officer of the School District, is hereby authorized to enter into an undertaking for the benefit of the holders of the Bonds from time to time, and any bond anticipation notes issued in anticipation of the sale of the Bonds, requiring the School District to provide secondary market disclosure as required by Securities and Exchange Commission Rule 15c2-12.

<u>Section 12</u>. This resolution shall not become effective unless a proposition approving this resolution is adopted at a special or annual School District meeting in accordance with Article 41 and Article 53 of the New York Education Law.

<u>Section 13.</u> After a proposition approving this resolution has been adopted and this resolution becomes effective, this resolution, or a summary hereof, shall be published in the official newspapers of the School District, together with a notice of the School District Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

Ordering a Special District Meeting to be Held on December 18, 2018 and Authorizing Related Matters

WHEREAS, the Board of Education (the "Board") of the City School District of the City of Oswego (the "District") adopted a bond resolution (the "Bond Resolution") on October 16, 2018 authorizing the reconstruction, improvement, rehabilitation, repair, furnishing and equipping of Oswego High School, Oswego Middle School, Fitzhugh Park Elementary School, Kingsford Park Elementary School, Riley Elementary School, Leighton Elementary School and Minetto Elementary School, including site work and the acquisition of original furnishings, equipment, machinery and apparatus required for the purposes for which such buildings are to be used, at a maximum estimated cost of \$63,100,000, and authorizing the issuance of up to \$57,200,000 serial bonds of the District and the expenditure of up to \$5,900,000 from the District's Capital Reserve Fund to pay the cost thereof; and

WHEREAS, the Board now desires to approve a proposition for submission to District voters, at a Special District meeting, seeking voter approval of the Bond Resolution, including the Capital Reserve Fund expenditure, as required by law.

NOW, THEREFORE, BE IT RESOLVED, by the Board as follows:

<u>Section 1</u>. The Board hereby orders and directs that a Special District Meeting shall be scheduled and conducted on Tuesday, December 18, 2018 at the District's designated polling places at (a) the Scriba Fire Station, (b)St. Paul's Church, (c) the Elim Grace Church, and (d) the Oswego Town Hall, at which time the polls shall be open between the hours of 12:00 o'clock Noon and 9:00 p.m., prevailing time, for the purpose of voting by machine on the following ballot proposition:

Proposition No. 1

Shall the bond resolution adopted by the Board of Education of the City School District of the City of Oswego (the "District") on October 16, 2018, which (1) authorizes the reconstruction, improvement, rehabilitation, repair, furnishing and equipping of Oswego High School, Oswego Middle School, Fitzhugh Park Elementary School, Kingsford Park Elementary School, Riley Elementary School, Leighton Elementary School and Minetto Elementary School, including site work and the acquisition of original furnishings, equipment, machinery and apparatus required for the purposes for which such buildings are to be used, at a maximum estimated cost of \$63,100,000; (2) authorizes the issuance of up to \$57,200,000 serial bonds of the District and the expenditure of up to \$5,900,000 from the District's Capital Reserve Fund to finance the cost of such capital projects; (3) authorizes the issuance of obligations of the District in a principal amount that may exceed the District's constitutional debt limitation; (4) provides for the levy of taxes on the taxable real property within the District to be collected in annual installments to pay debt service on obligations issued to finance such capital projects; and (5) pledges the District's faith and credit for payment of bond anticipation notes and such bonds, be approved?

<u>Section 2</u>. A public hearing shall be held at the Oswego City School District High School Cafeteria on December 4, 2018 at 2 Buccaneer Boulevard, Oswego, New York, at which the foregoing ballot propositions will be explained, and questions and comments from interested persons in attendance at the hearing will be entertained by the Board and District administration.

<u>Section 3</u>. The District's Board of Registration shall meet for the purpose of registering qualified voters of the District pursuant to Section 2604 of the Education Law at the Oswego County Board of Elections, 185 E. Seneca Street, Oswego, New York on December 4, 2018 between the hours of 9:00 a.m. and 4:00 p.m. Any person shall be entitled to have his or her name placed upon such register, provided that at such meeting of the Board of Registration, he or she is known or proven to the satisfaction of the Board of Registration to be then or thereafter entitled to vote at the Special District Meeting scheduled for December 18, 2018.
