Letter from Superintendent of Schools Dr. Dean Goewey

Since becoming superintendent of schools, we have made tough decisions that have enabled the district to avoid fiscal stress and create a responsible budget philosophy that focuses on our district's mission and vision. We make decisions based on critical staffing needs and the programs that support all our children. As an Oswego resident and tax payer, I continue to be intimately aware of our district's history relative to budgeting and spending. As a parent of three Oswego City School District graduates, I recognize the importance of extracurricular activities, such as sports, music and clubs. I also understand that our primary responsibility is to the instructional program for all students. These lenses provide the insight from multiple perspectives that I need to build a budget with the Board of Education that is responsible to our community, our district and our children.

As I have shared throughout the budget season across our community, I always try to strike a delicate balance between providing a quality core instructional program with being financially responsible to our district and community. The community has heard me say over the last four years that it is critically important to build a revenue-based budget that avoids the use of reserves or fund balance, as these are non-sustainable revenue sources that create problems in the future. The 2019-2020 budget is fully revenue based.

The great news again this year is that this budget includes important instructional positions and programs that support our mission and vision. These additions to the 2019-2020 budget will have a positive impact on teaching and learning! We are putting forth a budget for the 2019-2020 school year of \$86,034,274. Although this is a 2% larger budget than the current year, it is a very small budget increase for a district our size and includes many great opportunities for children. This budget is in alignment with our .007% tax cap.

Voting will be conducted from 9 a.m. to 9 p.m. on Tuesday, May 21 at four sites throughout the district. School district residents will cast their votes at the Scriba Fire Station, St. Paul's Church, Elim Grace Church and the Oswego Town Hall.

Budget at a Glance

Each year, the school budget is divided into three components: program/ instruction, capital and administration.



Program (77%)

Program represents the largest portion of the school budget, as it is involves the bulk of what helps the OCSD educational system and its staff members to lead students into becoming fully prepared and life ready.

Capital (14%)

This portion of the school budget is primarily centered on operations and maintenance. Debt service and specialty items also are included.

Administrative (9%)

Instructional support is vital for OCSD's operations. This portion of the budget is comprised of general support, instructional supervision and employee benefits attributed to each of those areas, including retiree benefits.

Basic STAR Exemption Impact

Three factors that determine the tax rate on your home include tax levy, equalization rates and property assessment. The tax levy is set by the school district in May; equalization rates are established by the New York State Office of Real Property Services in August and each respective town establishes assessments and equalization rates, but these are just estimates. Therefore, tax rates are not finalized until late August, at which time school tax bills are printed and mailed.

What Will Be Voted Upon?

Voters will cast ballots on propositions pertaining to the 2019-2020 Oswego City School District operating budget, two (2) Board of Education seats, the purchasing of new school buses, the Oswego School District Public Library, and two (2) library trustees.

BUDGET This year's proposed budget is \$86,034,274.

BOARD ELECTIONS	Two local residents have submitted petitions to serve on the Oswego City School District Board of Education.
	The candidates are: Heather DelConte and Lynda Sereno.
	The two candidates receiving the most votes would each serve a three-year term to commence July 1, 2019.
LIBRARY CHOICES	Pursuant to state law, the Oswego City School District Public Library appears on the ballot alongside the district's operating budget. The library and district budgets are not related and one does not affect the other. Voters will also select two members to the library board.
	The candidates are: Heather Wallace and William Schickling.

Proposition No. 1 - School Budget for 2019 – 2020 July 1, 2019?

Proposition No. 2 - Purchase of Buses

Shall the bond resolution adopted by the Board of Education of the City School District of the City of Oswego (the "School District") on April 2, 2019, which authorizes (a) the purchase of one (1) 34-passenger mini school bus at a maximum estimated cost of \$56,213; one (1) 34-passenger mini school bus with wheelchair lift at a maximum estimated cost of \$69,625; three (3) 66-passenger full size school buses at a maximum estimated cost of \$113,667 each; three (3) 66 passenger full size school buses (gasoline) at a maximum estimated cost of \$108,684 each; and one (1) full size wheelchair bus (gasoline) at a maximum estimated cost of \$118,109, at a total combined maximum estimated cost not to exceed \$911,000; (b) the issuance of up to \$911,000 serial bonds of the School District to pay the cost thereof, which amount may exceed the District's constitutional debt limitation; (c) the pledge of School District's faith and credit for payment of bond anticipation notes and such bonds; and (d) the levy of taxes on the taxable real property in the School District to be collected in annual installments to pay debt service on such obligations, be approved?

Proposition No. 3 - Public Library Vote

Shall the annual proposition be approved authorizing an annual appropriation of \$1,334,525.00 to operate the Oswego School District Public Library, and to support and maintain such library, which sum shall be raised annually by tax upon the taxable property of the Oswego City School District until changed by further vote of a majority vote of the electors of the Oswego City School District and shall be levied and collected yearly as are other general taxes?

Library Trustee – Five (5) Year Term (Vote for Two (2))

* The school district is obligated by law to place a proposition for library taxes on the ballot when requested by the library trustees. However, the library is a separate legal entity with its own funding and budget. Any money collected through taxation goes directly to the library and is for the sole purpose of library operations and programs.
