BE SURE TO ATTACH A COPY OF STUDENT'S LICENSE, REGISTRATION CARD and INSURANCE CARD. These items must be submitted before a student is eligible for a parking spot on school grounds.

Driving and Parking Rules

1. All automobiles parked on school grounds must be registered with the school.
2. Parking spaces are assigned by number-park in your assigned spot only.
3. All students must be licensed and covered by insurance. The school is not responsible for the automobile or its contents.
4. There is to be no loitering in the parking lot. There is no smoking/vaping in vehicles on school property.
5. The speed limit is 15 miles per hour. Any form of reckless driving on school grounds will not be tolerated. Reckless driving will be cause for loss of parking privileges.
6. Parking regulations are strictly enforced. It is a privilege to park on school grounds. Suspension of parking privileges may occur if school rules are violated.
7. Excessive tardiness, or absences will result in parking authorization to be revoked.
8. These rules are the main areas of concern, and by no means inclusive.
9. Your parking tag must be displayed. If an additional vehicle will be driven at anytime, you must have you parking tag displayed in the vehicle.

Be advised that because your vehicle will be parked on school property, you are authorizing school officials to do vehicle searches upon suspicion, or suspicious activities.

Parking Guidelines Agreement

Parking a vehicle on school grounds is a privilege.

Permission will be granted at the beginning of each school year at the discretion of the administration. Simply completing the application process does not allow a student to park on school grounds.

There is a direct connection between students with vehicles and student issues regarding tardiness, and skipping school. A strong stand will be taken to eliminate these issues. A student wishing to park on school grounds must complete an application through the Main Office. The application process is not complete until all forms are signed by all parties and a parking tag is issued. Students must comply with rules and regulations as specified on the application.

Parking privileges will be revoked for the following violations:

- Speeding
- Parking violations
- Being in vehicles during the day
- Leaving school grounds without permission
- Arriving late to school
- Students must be here on time. After 3 tardies parking privileges may be revoked.
