The Board of Education declares the results of the canvass, all in accordance with 2610 (3) of the New York State Education Law; and the Board of Education has duly examined the statements of the result of said annual election held May 16, 2017 as aforesaid, in each of the school election districts of said City School District and the results are as follows:

**Section 1** – From a canvass of the returns as contained in each statement of the result of the Annual City School Election of the City School District of the City of Oswego, New York, held on May 16, 2017, it is hereby found and determined that the number of votes cast for the candidates for Member of the Board of Education of said City School District in the several school elections districts of said City School District is documented (as per attached).

**Section 2** – It is further found that from the tabulation of the results of said annual election and propositions in the several school election districts that Brian Chetney, Samuel Tripp and Brandon Lagoe are elected to the Office of Member of the Board of Education of this City School District for a term of three years, which will commence on July 1, 2017 and which will expire on June 30, 2020. The 2017-18 budget proposition tabulation as well as the propositions including, the purchase of five (5) 66- passenger school buses and the Oswego School District Public Library funding is final (as attached).




