RESOLUTION OF THE BOARD OF EDUCATION OF THE OSWEGO CITY SCHOOL DISTRICT

To Appoint a Probationary Classroom Teacher

WHEREAS, the Acting Superintendent of Schools Mr. Christopher Todd (the "Acting Superintendent") recommends that Alex Goewey ("Mr. Goewey") be appointed by the Board of Education ("Board") of the Oswego City School District (the "District") to a probationary term as a Health/Physical Education probationary teacher, at an annualized salary of \$53,133, minus applicable withholdings and deductions;

WHEREAS, Mr. Goewey possesses the following certifications: Health Education, Initial Certificate, pending approval, and Physical Education, Initial Certificate, pending approval;

BE IT FURTHER RESOLVED, that nothing in this resolution shall be construed to limit the unfettered statutory right of the school district to terminate Mr. Goewey for any statutorily and constitutionally permissible reason while he remains in probationary status.
