Here is what you need to do:

- **Complete and sign** the attached COA form for **all** adults and children in your household.

AND

- **Mail, Fax, or Email** the completed COA form **AND** proof of residence.

We must receive proof of residence to process the change

Acceptable Proof of Residency (SUBMIT **TWO** ITEMS):

- ❖ **1 REQUIRED - MAJOR UTILITY BILL(GAS, ELECTRIC, WATER) OR MORTGAGE, LEASE/RENTAL AGREEMENT, HOUSE PURCHASE AGREEMENT**

PLUS 1 OF THE FOLLOWING:

- INCOME TAX FORM
- VEHICLE/HOME INSURANCE POLICY
- PAY STUB
- VOTER REGISTRATION DOCUMENTS
- OFFICIAL DRIVER'S LICENSE, LEARNER'S PERMIT OR NON-DRIVER IDENTIFICATION
- STATE OR OTHER GOVERNMENT ISSUED IDENTIFICATION
- DOCUMENTS ISSUED BY FEDERAL, STATE OR LOCAL AGENCIES (E.G., LOCAL SOCIAL SERVICE AGENCY)

- ❖ **Once received and processed we will notify your child (ren's) school(s) and Transportation of your move so you don't have to contact them.**

- ❖ **Please note K-6: Your new residence may be located in a different elementary school zone and therefore may result in your child changing schools.**

Student Residency Questionnaire
